PUBLIC HEARINGS:

a. Public Hearing: 2019 Weed Abatement Protest Hearing and Issuance of Abatement Order. Chief Lieberman presented the properties on the list for the weed abatement protest hearing. He reported that there were triple the amount of properties on the abatement list compared to the last five years. This could be an issue compared to the \$12,000.00 budget available. Chair Nicolls asked if anyone would like to come forward to protest being on the abatement order. Two members of the public did come forward; however it was confirmed that they were not on the list for abatement. Action: Board Member George moved and Vice Chair White seconded the motion to close the public hearing and issue an abatement order to the Fire Chief to have the weeds removed on the properties reported on the list.

1. Consideration of Fiscal Year 2019-20 Budget. Chief Lieberman presented the staff report for the proposed budget for Fiscal Year 2019-2020. Chair Nicolls asked for public comment. Sean McMahon, President of Local 4403, thanked the Board and expressed appreciation for the three full-time Firefighter positions that will start in the new fiscal year. He also explained that this is not an increase to staffing levels, but transitioning part time positions to full time. FIRE CHIEF ITEMS:

- a. Firefighter recruitment will start today. The tentative start date is the end of August 2019.
- b. An FCFA Captain experienced a medical emergency while at work. Chief Lieberman thanked Engineer LoPresti and Firefighter Rawson for their efforts during this difficult situation.
- c. Truck 5 is being road tested today. Annual ladder testing needs to take place prior to Truck 5 going into service.
- d. Captain Ferguson is an Acting Battalion Chief for a few days this week.
- e. Chief Lieberman has applied for grant funding to create a Community Wildfire Protection Plan(CWPP). The county has adopted a CWPP and local jurisdictions have opportunities to create their own, which will help educate the community on how to avoid wildfires. The grant would focus on the open space areas of Arroyo Grande.
- f. Chief Lieberman is working with the county regarding Class B firefighting foam that is stored at the Oceano Airport. The County of San Luis Obispo has environmental concerns.

BOARD COMMUNICATIONS:

Vice Chair White reported that Oceano Community Services District is planning on having a special tax election in March of 2020. Board Member George reported that the City of Arroyo Grande council approved the proposed Five Cities Fire Authority FY 19/20 budget and continues to support FCFA.
