a. Consideration of Approval of a Resolution for Acceptance of a Donation from the Grover Beach Community Foundation for Purchase of Nozzles and Training Equipment, Appropriation of the Donation. Chief Lieberman presented the staff report to the Board. He reported on the generous donation from the Grover Beach Community Foundation to purchase nozzles and a smoke generator for training purposes. This donation will allow the purchase of a full complement of nozzles for one fire engine.

c. Fire Chief Report-Annual Weed Abatement Program and County of San Luis Obispo County Grand Jury Report "Fire Risk Management-Cities Do It-Why Not the County"? Chief Lieberman shared with the Board a Grand Jury report that Five Cities Fire Authority received and he will be responding to regarding weed abatement. The County is evaluating options for a weed abatement program. His presentation to the Board included the challenges that Five Cities Fire Authority has faced with their current weed abatement program. The Chief suggested that the Board may want to consider modifying the current program. He explained the focus should move towards clear fire threat areas, rather than "neighborhood blight". Chief Lieberman asked the Board to review the Grand Jury report and he will bring back a draft response for Board review. Board Member Storton suggested to bring the current weed abatement program back for review to discuss more effective options. No public comment received.
