SUBJECT: Update of Regular Board Meeting Schedule

RECOMMENDATION

It is recommended the Board adopt a resolution updating the schedule for regular Board meetings including the frequency, day, time, and location and establishing a regular meeting for January 29, 2024.

BACKGROUND

On June 22, 2023, the Board took action to establish a schedule for regular Board meetings which identified the frequency, day, time, and location for these meetings. In addition to regular meetings held on August 21, 2023 and October 16, 2023, beginning in 2024 regular meetings will be held in January, April, July, and October on the third Monday at 5:00 p.m. The meeting location is the city in which the rotating Board Chair represents and as such, the location for 2024 meetings is the Grover Beach Council Chamber as the current Board Chair represents Grover Beach.

However, subsequent to adoption of the schedule, staff realized that the third Monday in January is the Martin Luther King, Jr. holiday. Given this holiday conflict along with other schedule conflicts that particular week, staff worked with the Board to cancel this regular meeting and schedule a special meeting instead on January 29. To avoid this holiday conflict in the future, staff is recommending the Board adopt a resolution (shown in Attachment 1) updating the regular meeting schedule by stating that if a day of a regular meeting is a holiday, then the meeting would automatically be moved to the next day of Tuesday. Special meetings of the Board could continue to be called outside of the regular meeting schedule.

Lastly, the attached resolution also establishes a regular meeting for January 29, 2024 at 5:45 p.m. following the special meeting. Establishing this regular meeting is necessary given agenda items that must be approved at a regular meeting including appointment of an Interim Fire Chief and approval of a professional services agreement for General Counsel. Agenda items for this proposed regular meeting have been posted 72 hours in advance for transparency and Board consideration pending the Board's adoption of this resolution.
